ORDINANCE NO. 331

AN ORDINANCE REGULATING CITY REFUSE SURCHARGE RATES; CORRECTING CODIFICATION ERROR; ESTABLISHING RATES.

BE IT ORDAINED AND ENACTED by the Governing Body of the City of Pawnee Rock, Kansas:

Section 1. When codified in 2011, the city code of Pawnee Rock regarding surcharges allowed the city on monthly refuse collections was erroneously set at \$1.50 per month. The codification did not include the actual cost of refuse collection surcharges which at the time of codification was set by ordinance at \$2.50 per month. This ordinance does not increase rates, it corrects that codification error.

Section 2. Section 15-516 of the Code of the City of Pawnee Rock, Kansas (2011) setting rates for monthly costs and charges the city receives as a surcharge on the costs defraying collection and disposition of solid waste is hereby amended to read as follows:

15-516. SAME; FEE SCHEDULE. (a) The monthly charge to the city for refuse pickup in Pawnee Rock, Kansas shall be ~~\$1.50~~ \$2.50 over the actual cost to the City for refuse pickup.

(b) Additional pickups per week will be charged a predetermined amount and based on regular rates. Where one container is used for more than one housing unit, the charge will be based on housing units.

Section 3. REPEAL. Prior Code Section of the City of Pawnee Rock 15-516 (2011) is hereby repealed.

Section 4. EFFECTIVE DATE: This Ordinance shall take effect and be in force from and after its publication in the official city newspaper or from and after compliance with K.S.A. 2012 Supp. 12-3007(b).

ORDINANCE NO. 331

This ordinance for the City of Pawnee Rock changes 2011 Code Section 15-516 to correct a codification mistake and typo. In 2011 the city of Pawnee Rock codified ordinances into a new code. Section 15-516 governed the surcharge rate for trash and refuse pickups. At that time the surcharge was \$2.50 per month over the cost of the trash company's charges. The codified section, however, was set inadvertently at \$1.50 per month. By moving the amount back to \$2.50 per month, it merely charges what has been charged per month since 2011.
