ORDINANCE NO. 327

AN ORDINANCE SETTING THE TIME OF MEETINGS OF THE CITY COUNCIL OF PAWNEE ROCK; AMENDING SECTION 1-203 OF THE REVISED 2011 CODE OF THE CITY;

BE IT ORDAINED AND ENACTED by the Governing Body of the City of Pawnee Rock, Kansas:

SECTION 1. Section 1-203(a) of the 2011 Recofified Code of the City of Pawnee Rock is hereby amended to read as follows:

1-203. (a) Regular meetings of the governing body shall be held on the first Monday of each month at ~~7:30 p.m.~~ 7:00 p.m. In the event the regular meeting day shall fall on any legal holiday or any day observed as a holiday by the city offices, the governing body shall fix the succeeding day not observed as a holiday as a meeting day.

SECTION 2: Such other ordinances or portions of existing ordinances of the City of Pawnee Rock as are in conflict with this ordinance are hereby repealed.

SECTION 3: This Ordinance shall take effect and be in force from and after its publication in the official city newspaper of the City of Pawnee Rock, Kansas or from and after compliance with K.S.A. 2012 Supp. 12-3007(b).
