**ORDINANCE NO. 332**

**AN ORDINANCE REGULATING MOTORIZED VEHICLES; AMENDING THE EXISTING CITY CODE OF PAWNEE ROCK REGARDING THERETO; REPEALING PORTIONS OF EXISTING ORDINANCES.**

*BE IT ORDAINED AND ENACTED by the Governing Body of the City of Pawnee Rock, Kansas:*

Section 1: PURPOSE. To curb the improper and illegal use of certain motorized vehicles within city limits, the following amendments to existing city code are adopted.

Section 2: Article 301 of chapter 14 of the Pawnee Rock City Code is hereby amended as follows: 14-301. REGULATION OF MOTORIZED VEHICLES. It is unlawful for any person to operate, or ride, any unregistered motorcycle, trail bike, pocket bike, motorized bicycle, go-cart, all-terrain vehicle, or motor scooter on private property except for purposes of loading or unloading said vehicle; on the city streets, alleyways or on any property owned by any municipality; provided that if said vehicle is duly and properly registered with the state of Kansas and is displaying a license plate, it may be ridden or operated on city streets only. Definitions:

- (a) "All terrain vehicle" shall be defined as set forth at K.S.A. 8-1402(a);
- (b) "Pocket bike" shall be defined as every device having two tandem wheels, or three wheels, which may be propelled by a gasoline engine and which the headlights are lower than 24 inches, its tailpipe is lower than 15 inches, and no vehicle identification number is located on the vehicle nor can ownership of the vehicle be registered.
- (c) "Motorized Scooter" shall be defined as a vehicle consisting of a footboard between two small end wheels controlled by an upright steering handle attached to the front wheel, propelled by an electric or gasoline motor.
- (d) "Motorized Bicycle" means the same as set forth at K.S.A. 8-1439(a).
- (e) "Motor-driven cycle" means the same as set forth at K.S.A. 8-1439.

Section 3: Article 302 of chapter 14 of the Pawnee Rock City Code is hereby amended as follows: 14-302. OPERATION PROHIBITED. The operation of any of the above-described vehicles upon the streets, roads, and alleys within the corporate

limits of the City of Pawnee Rock contrary to any provision of Section 14-301 is hereby prohibited.

Section 4: REPEAL. Appropriate sections of Ordinances 328 and 328a of the City of Pawnee Rock that are inconsistent with this Ordinance are hereby repealed.

Section 5: This Ordinance shall take effect and be in force from and after its publication in the official city newspaper of the City of Pawnee Rock, Kansas or from and after compliance with K.S.A. 2012 Supp. 12-3007(b).
