**ORDINANCE NO. 333**

**AN ORDINANCE PROVIDING FOR THE GENERAL ASSESSMENT OF COURT COSTS IN THE MUNICIPAL COURT OF PAWNEE ROCK; PROVIDING FOR THE SALARY OF THE MUNICIPAL JUDGE AND CLERK OF THE MUNICIPAL COURT; AMENDING SECTIONS 9-107, 9-108 AND 9-109 OF THE REVISED ORDINANCES OF THE CITY OF PAWNEE ROCK.**

BE IT ORDAINED AND ENACTED BY THE GOVERNING BODY OF THE CITY OF PAWNEE ROCK, KANSAS

**Section 1.** 9-107. SALARY OF MUNICIPAL JUDGE. SAME; SALARY. The municipal judge shall receive a salary of \$150.00 per month.

**Section 2.** 9-108. SALARY OF MUNICIPAL COURT CLERK. 9-108(c) The municipal court clerk shall receive a salary of \$8.33 per month for municipal court duties. If the municipal court clerk is an existing municipal employee, whether salaried or appointed, of the City of Pawnee Rock, the salary for Municipal Court Clerk shall be in addition to any other salary or compensation to said employee.

**Section 3.** 9-112. COURT COSTS. (a) There shall be charged as costs in all cases commenced in the Municipal Court of the City of PAWNEE ROCK, Kansas, upon uniform notice to appear and recognizance for appearance, or the filing of complaint and issuance of warrant or notice to appear, charging violations of the ordinances of the City of PAWNEE ROCK, the sum of SEVENTY-SEVEN DOLLARS and FIFTY CENTS (\$77.50). From this amount, the state assessments from court costs under KSA 12-4117 shall be deducted and remitted as required by law. Such remaining sum for court costs shall be entered on the Court docket and assessed by the Municipal Judge of the City in all cases after entry of a plea of guilty by the defendant, a plea by the defendant of nolo contendere, or upon conviction of the defendant after formal trial.


(b) The costs so assessed and collected pursuant to the provisions of subsection 3(a) of this ordinance shall be deposited in the City's General Fund together with all fines collected in such cases.


**Section 4.** REPEAL: Subsections 9-107, 9-108(c) and 9-112 of the codified 2011 ordinances of the city of Pawnee Rock, and all other ordinances contrary to the provisions of this ordinance, are hereby repealed.

**Section 5.** EFFECTIVE DATE: This Ordinance shall take effect and be in force from and after January 31, 2015, and its publication in the official city newspaper, or from and after compliance with K.S.A. 2012 Supp. 12-3007(b).
